Waterline Replacement Along Romy Drive

The Contractor has mobilized on site and should begin installing waterlines next week.

Back-Up Waterline and Booster Pump Installation at NTP

The 4" waterline has been installed. We hope to have the pump and discharge lines complete within the next few months.

Bayou Blue System Improvements

We signed an engineering agreement with Picciola and Associates for a proposed Booster Station in the upper Bayou Blue area. We anticipate having a kickoff meeting within the next few weeks.

Valentine Booster Station Rehabs

CSI Services is currently painting new and existing piping. Once this is complete all rehab work for Valentine Booster will be complete.

Waterline Replacement Along East 148th Place, et al

Construction is complete on both E. 148th Place and East 177th Street.

Waterline Replacement Along Cheramie Lane, et al

Muddy Pipeworks, LLC is the Contractor for this project. Work should begin within the next couple of weeks.

STP - Basin Leak Repairs

Basins 4 and 5 have minor leaks in various locations, causing standing water to collect on the walkway and grassed area between Basins 4 and 5. We previously contracted Baker Construction to prepare similar leaks on Basin 8, and the product worked well. We are awaiting pricing to perform repairs on Basin 5 in November. Once we recieve a quote we will present to the Board for approval.
